Instructions to the Candidates:

Status Retention :

- 1. All the candidates to whom a seat is allotted must join the allotted College with all original documents within the prescribed time.
- 2. This allotment is done on the basis of Information submitted by the candidate and the allotted college will verify all the original documents of the candidate and ascertain the eligibility as per the Information Brochure and allow joining only if found eligible.
- 3. If a candidate gets selected for a particular college, then the candidate is required to join that college as per the procedure. In case he/she does not join the college, he/she will not be eligible for subsequent admission process.

- 4. If a Candidate after joining is satisfied with the allotment, such a candidate may submit a Status Retention Form. Filling of Retention form is Not Mandatory and is choice of the candidate.
- 5. Candidate who has submitted status retention form will not be eligible for remaining subsequent round(s).
- 6. If any candidate to whom a seat has been allotted in the 1st round does not join the college and course seat so allotted, it will be presumed that such a candidate is not interested in the admission process and for all further CAP round(s) including MOP-UP round(s) of admission, such candidate shall not be considered for allotment of any seat.
- 7. All candidates should refer to the Information Brochure Published on the website for rules and regulations.
