❖ **Online Preference / Choice Filling :**

- 1) In view of the letter given by DMER, the choice filling process will be started for this round only.
- 2) All the preference filled in previous rounds will be null and void.
- 3) Candidates who have filled status retention in previous rounds can also apply for this round. However, in that case the retention form filled will be deemed to be cancelled.
- 4) Those candidates who do not wish for any change /betterment in this round shall not fill the choice for this round.
- 5) Seat becoming vacant due to betterment in this round will be filled in this round as per merit and choice.
- 6) The seat allotted and joined by any candidate will not be vacated unless the candidate is upgraded or the seat is canceled by the candidate
- 7) Candidates having a seat in hand as on 05.30 pm of 08/11/2024 pm will not be eligible for Institute level round.
